Kelly gives Paul a kiss much to the disgust of the girls

Tara/Holly: Ah, that's gross

All sing along to the music

Kids sing louder and start to bat balloons around in the back of the car

Paul: Excuse me. I didn't say any singing was allowed. Okay

Cut back to Sam who meets and greets Leo also in white overalls

Sam: I thought you were in Sheffield

Leo: Just getting on the train when I was bleeped

Sam: Oh, well, there's nothing like being thrown in at the deep end

Leo: Yeah. I just knew this week had been too easy

Nighttime. Truck driver, Ash Williams, HGV

New Scene 10:00:52

Nighttime. Two lads in a BMW. Passenger, Mick Stevens, has an injured hand. Richard Barrett is driving. Mick's in obvious pain

Richard: How you doing mate

Mick: It's fine

Richard: You're gonna have to hold up, alright

Mick: Yeah

Richard: Just hold on

Cut back to Sam and Leo, walking

Leo: I can think of cheaper places to live than here

Sam: Well, Sheffield for one, but you'd have been mad to turn the job down

Cut to our pov looking at the back of a van driver's head

New Scene 10:01:16

Cut to our pov from his passenger seat

New Scene 10:01:17

Cut to our pov from the road, looking at the BMW

New Scene 10:01:19

Cut to inside the BMW. Their journey is urgent. They speed up

Mick: Alright

New Scene 10:01:22

Cut back to Sam and Leo, still walking

Sam: How's your daughter, is it Tessie?

Leo: Cassie. She's fine about it

Sam: How old is she

Leo: Eleven

New Scene 10:01:28

Cut to a group of students walking, drunken, having a good time

New Scene 10:01:33

SILENT WITNESS - THE FALL OUT - PART ONE OF TWO

Cut back to Sam and Leo. Now aware of people running and shouting, busyness that we can't see Leo: Who do you reckon's in charge here

Sam: Well look out for a traffic seargeant. They normally take control

New Scene 10:01:41

Cut to Emma Charlston in the passenger seat of a Merc. She looks at the driver who we can't see. She's is obviously very unhappy. She undoes her seatbelt and reaches into the back Emma: Do you want a fag?

Cut back to Sam and Leo as they meet up with a police officer Harding: Seargeant Terry Harding
Sam: Are you traffic investigation unit?
Harding: That's us

Introductions Sam: Dr Leo Dalton. I'm Professor Sam Ryan

New Scene 10:01:59

Cut back to Ash. Yawning

New Scene 10:02:02

Cut to external shot of truck

New Scene 10:02:04

Music in 10:02:04 - The Irish Rovers by The Pogues - Duration 00:09

Cut to another truck driver, John Brent. Eating a burger. Looks in wing mirror. A car wants to overtake

New Scene 10:02:13

Cut back to Sam, Leo and Harding walking. Now aware of much shouting. The night is brightly, unnaturally lit Sam: How long ago did it happen
Harding: An hour or so

New Scene 10:02:16

Flash quickly between various scenes now
Cut back to the lads in the BMW Mick: Floor it Rich

Cut back to van driver. Concerned. Watching
behind him. Grabs his mobile

BMW overtakes at high speed

Van driver fumbles and drops his phone

BMW swerves in front of truck

Ash falls asleep

Red traffic light

Drunken students crossing road. Look in
horror at the truck which doesn't stop

Cut back to Emma - no seatbelt - screaming.
Moment of impact. Her head hits the dashboard

Cut to cars swerving. BMW cutting in. John
shouting. Family in panic as Paul tries desperately
to stop

Harding: Bloody great mess

Sam and Harding walk through the mess

Harding: She's over here. Looks like she's the
one from the Merc

Part One

Spots a broken rear light bulb on the road

Harding: That's mine. No-one touch it please.
Sean

Sam looks at Emma's body lying on the
road. One of her heels is grazed

Ash is wrapped in a red blanket. He appears
to be unhurt but in shock.
A medic leads him away

Paramedic: You okay mate. You okay. Come
on, let's get you in the back of the ambulance

Sam looks inside the Merc. She uses a torch to
check the blood pattern. There's blood on
the driver's side of the dashboard

Sam, Leo and Harding walking amongst the
wreckage

Harding: I think the van was hit by the artic. Lost
control and went into the lamppost. That's where
the petrol tank is on these

Sam: How many were in it?

Harding: Just the one as far as we can tell. Italian
plates

Sam: Have you got pictures of this

Harding: Some. Soco will get those

Sam leaves them to check out the van

Leo: How many fatalities

Leo and Harding approach the BMW. Richard
is being attended to by a medic. Mick is dead

Harding: Ten. And counting. The one you
want's on the passenger side

Leo: Right

Paul is unhurt. He stands and cries as Kelly is wheeled past on a stretcher

Sam looks inside the van. There has been a fire here and the charred corpse is still sitting in the driver's seat

Paul cuddles Tara who is also unhurt

The van driver's partly melted mobile is on the floor where he dropped it

Sam peers more closely at the corpse. She takes some clingfilm and puts it over his mouth to preserve his teeth. A voice behind her
Introductions

Deacon: Keeps everything nice and fresh. I swear by the stuff. DCI Carol Deacon

Sam: Sam Ryan. Pathologist

Deacon: Good to meet you

Sam moves on Deacon looks around the van then turns to watch as her DS, Johnson, leans into the Merc and drops an empty half bottle of whiskey onto the seat. She nods at him

Sam is standing near John who is wrapped in a silver blanket and appears unhurt but shocked. A police officer checks him. Sam turns when her name is called by another officer

Officer: Dr Ryan

Sam: Yeah

Officer: You're wanted

Cutting gear being used on Paul's car watched by Harding, his Inspector and Leo

Sam approaches them

Harding: We should be able to get some vital stuff from that. I'll take a look when we get back to the hangar. I'll have a word with the professor. I think you ought to see this

Nods at the departing Inspector

Sam: Is that your guv'nor

Harding: Yeah

Nods towards Deacon standing on the edge of the scene with Johnson

Sam: So who's she

The roof is lifted off the family car. Holly's body lies on the back seat

Harding: I don't know. I'll check her out

Nice house. Karen sits on the sofa, glass in hand, watching the tv. She hears the front door open and close. Nick comes into the house. He doesn't respond. We see that he is bloodstained and shocked. She puts down her glass and rises to check out why he hasn't spoken to her. He staggers into the loo, lifts the seat and throws up. Karen comes down the stairs, sees him, obvious worry

Karen: Nick. I'm in here

Karen: Nick?

Karen: Nick? What happened

New Scene 10:07:59

Back at the accident scene. Deacon chats to Leo. Sam and Harding are behind them and some distance away

Deacon: I hear this is a new post for you

Leo: Very new, yes

Deacon: Have you got children?

Leo: One. You?

Deacon: No. If you need anything at all, information, what-have-you, just let me know

They separate

Leo: Thanks

Sam: Have you found out who she is

Harding: She's a DCI from the Met. She's got an interest in one of the victims involved in the accident

New Scene 10:08:24

In Karen and Nick's kitchen she's helping him to take his trousers off so that they can see what the damage is. There's a lot of blood and Nick is in a lot of pain

Nick: Help me get them off

Karen: Nick, I've got to get you to a hospital

Nick: I'm not going to a hospital

Karen: Nick

Karen: I've been in an accident. A pile up. I've been drinking

Karen: Shit! Nick

Nick: It wasn't my fault

There's a huge open wound in his thigh

Karen: You're gonna need stitches. This is a mess

New Scene 10:08:50

Back to the accident scene. Leo and Harding are examining the road. Deacon passes on her way to the Merc. She leans in through the window

Harding: This is the BM's tyre mark. It's striated. It would appear the driver was trying to steer it one way but it just wasn't having it

Leo: Any idea what might have caused that to happen?

Harding: It's hard to say at the moment

Sam calls out urgently from another part of the scene. She needs to stop one of the breakdown vehicles from winching the van. Deacon take the opportunity to remove the mobile phone from the Merc. She puts it into her pocket. Harding stops the winching and he and Leo join Sam. Deacon also joins them

Sam: Hold it! Can you get him to stop

Leo: What is it?

Sam: I'm not sure

Deacon: What the hell is that?

Sam: It's an arm. It's somebody's arm. Tell him not to move

Authoritatively

Deacon: Turn it off

To Leo

Sam: I'm gonna need something to put it in. And see if you can find out who it belongs to

Deacon: I would think one of the fatalities

Sam: It could be one of the injured, which is why we need to move quickly. There's no fresh blood

Deacon: So?

Sam: There should be fresh blood

Returning with a bag

Leo: I've had no reports of a severed limb

Deacon: So it is one of the fatalities

Sam carefully lifts the arm and puts it into the bag. They look at it more closely

Sam: Thanks. It's undergoing post mortem

change. The tissues are discoloured

Leo: That's weird

Deacon: What is?

Sam: This limb's been severed from the rest of the body for some time

Deacon: Some time? What, an hour, two hours?

Sam: No

Leo: Much longer than that

Sam: It hasn't happened in this accident. It could have been in one of the vehicles

Deacon: I don't think we should jump to any conclusions just yet

Sam: The limb's had to have come from somewhere

Leo and Sam walk away

Sam: Will you ring Harry, let him know there's a little extra arriving

Reporter: It's impossible for us to get any closer to the scene. The Police....

New Scene 10:10:44

Cut to the mortuary admin office where Rosemary is switching off lights. The tv news is on. Harry is watching. The news bulletin runs over their conversation

Reporter:are keeping people well back. All I can see from here is the tangled wreckage of cars and lorries. Nobody knows how many vehicles are involved but it's a horrific crash which is going to take some time to clear up

Rosemary: Looks nasty

Harry: Yep. And I bet it's coming this way

Reporter: One vehicle I can tell you burst into flame. Fire fighters are still around the vehicle concerned that the fire doesn't start again and spread.

Rosemary: I can stay

Harry: No. You get out of here

Rosemary: You sure?

Rosemary leaves

Harry: One of us has to have a social life

Harry switches off the tv

Reporter: Cutting apparatus has been used to free people from the wreckage and the emergency services....

New Scene 10:11:12

In the mortuary cutting room, Harry and two technicians are cleaning up. The phone rings

Harry: Hello. Hi Leo. An arm without a body. Is this the crash? I take it there's more than just an arm then. Really?

New Scene 10:11:39

Sam and Leo arrive at her flat

Sam: Come on in

Appreciates the decor

Leo: Ooh, now I know what I'm aiming for. This is nice

Sam: Do you fancy a drink

Leo: I'd kill for a beer

Sam: In the fridge, in the kitchen. Could you get me one too

Leo: Sure

Sam: I just want to make a quick call, see what I can find out about DCI Deacon

Leo: She seemed alright to me

Sam: Yeah, I like to know who I'm working with

New Scene 10:12:09

Deacon and Johnson arrive at the hospital.
A woman is being comforted by her family.
This is Mick Stevens wife

Deacon: Mrs Stevens. Detective Chief Inspector Carol Deacon, Metropolitan Police. I'm really sorry

New Scene 10:12:25

Richard is in a hospital bed. He's unconscious and attached to monitors. A junior doctor is

with him. Deacon and Johnson enter the room

Johnson: DS Johnson, DCI Deacon. When do you think Mr Barrett will be able to talk to us

Doctor Logan: You'd better speak to Doctor Peters

Deacon: A rough idea

Doctor Logan: Not for a while. Certainly not for a while, he's very poorly

Deacon: Could you get Doctor Peters for me please

Doctor Logan: I can try, but he's the only neuro registrar on call tonight

She leaves

Deacon: I want that officer to remain on the door. The only person he speaks to is either you or me

New Scene 10:13:02

Sam is finishing her phone call

Sam: Yeah, if there's anything else, will you let me know. Okay, bye David, bye

She hangs up. Leo brings two beers

Leo: Learn anything?

Sam: She's a high flyer. Future Commissioner material

Leo: I'd have curtsied if I'd known. Any idea what her interest in the crash might be?

Sam: She's interested in one of the victims. Involved in some misdemeanour or other

Leo: I wonder which one

New Scene 10:13:24

Harry has fallen asleep at his desk. Ann, his mother, enters the room. He wakes with a start

Ann: Harry. Harry. Harry. You wanted me to wake you. I'm just on my way out. You know, you really shouldn't study so hard, you're gonna make yourself ill

Harry: I wasn't studying last night. I had to stay late and log crash fatalities

Ann: All the same. And I'm out tonight. Covent Garden

Harry: Thanks for waking me

Leaving

Ann: Okay

Harry's head drops again. He sits up sharply, hit's himself round the face, stands and switches the tv on. News report

Reporter: The accident happened yesterday evening and, as yet, it is not clear what caused the multi vehicle pile up. The police accident investigation unit are still on the scene and recovery vehicles have been working through the night in a bid to clear the road

Music in 10:14:20 - Specially Composed - Duration 01:10

Some time later, Harry stands in the middle of the room. The tv is off and he is deep in thought. He suddenly looks at his watch and starts to grab papers off his desk

Harry: Shit!

New Scene 10:14:26

Harry leaves the house. Jumps into his car. Drives away

New Scene 10:14:41

Sam is walking to the university building

New Scene 10:14:52

Sam enters the lobby. Rosemary comes out of her office

Rosemary: Sam. For you

Sam: Thanks Rosemary

Rosemary: Just arrived. Nice looking courier. From last night is it?

Sam: Yeah

Rosemary: Yeah, I heard it on the news, it sounded crazy

Harry arrives

Sam: It was. Eleven fatalities

Harry: Eleven?

Sam: It could end up being more

Sam and Harry continue to her office

Harry: This arm? What's that about?

Sam: I'm not sure

Harry: It's suspicious though?

Sam: I think an arm without a body is definitely suspicious

Harry: Do you mind if I work on it? It can go towards my exam

New Scene 10:15:23

A police car approaches a block of nice looking riverside dwellings

New Scene 10:15:27

Inside Karen and Nick's home. Johnson can be seen outside as he knocks on the door. Karen answers. She doesn't invite him in

Johnson: Detective Sargeant Johnson, Metropolitan Police. Does a Nicholas Connors live here?

Karen: He's at work

Johnson: Are you Mrs Connors?

Karen: That's right

Johnson: You are no doubt aware that last night your husband's car was involved in a traffic accident

Karen: No

Johnson: At about nine o'clock?

Karen: It's nothing to do with Nick. He was with me

Johnson: The car is a Mercedes registered in your husband's name

Karen: Oh, no, wait, he came home by taxi last night. So, I don't know

Johnson: Where does he work. We'd like to speak to him

New Scene 10:16:06

Sam and Harry look at photos of the arm

Sam: Do you notice anything?

Harry: Tissues look discoloured

Sam: They are

Harry: I don't get it. That means that it can't be the result of the crash

Sam: Exactly

Harry: I thought the body must still be in the wreckage somewhere

Sam: No. It's a rogue arm. It doesn't belong to anybody. So I'm going to radiograph it and keep it intact and hopefully we'll find a match. Can you ring round mortuaries, hospitals, find out if they've had anyone in with a missing arm

Harry: Yeah, sure

New Scene 10:16:38

Police station. Deacon enters reception where John Brent is waiting for her

Deacon: Mr Brent?

John: That's right

Deacon: Would you like to come through

New Scene 10:16:49

Sam's office. Harry's on the phone. Leo has just arrived

Harry: Yeah, anything at all

Sam: I'm just about to make a start on these bodies

Leo: Give me five minutes and I'll be with you. Who are we kicking off with?

Sam: The two unidentified ones

Leo: Two?

Sam: The girl driving the Merc. No ID

SILENT WITNESS - THE FALL OUT - PART ONE OF TWO

Leo: Can't we put a trace on the car registration?

Sam: It wasn't her car

Finishes phone conversation

Harry: Yeah. Okay, thanks anyway

Sam: I'll take her, you take the fire victim. The teeth should be intact at least

Picks up the photos

Leo: What about this arm

Harry: I've tried the other mortuaries and half a dozen hospitals. So far, no joy

Leo: Probably something very obvious

Sam: I wish I had your optimism

New Scene 10:17:23

John Brent is giving his statement. Intercut with flashbacks of the accident

John: I couldn't believe what I was seeing. It was insane. I felt the impact push me forward, and my truck's a big vehicle. Then there was this other impact and we moved forward again. I didn't know 'til later it was a family. Two kids, that right?

Deacon: That's right

John: I didn't know that. Not at the time

Deacon: Anything else?

John: No. Nothing else

Deacon: Alright. Thanks

John: Do I have to record it, My statement?

Deacon: No. We only do that when we're questioning people

Perplexed

John: Have I got to sign anything?

Deacon: Not just at the moment

Deacon: I'll get you to come back at a later date,

Deacon and Johnson walking

Deacon: We didn't get anything from the phone in the van

Johnson: Not surprised, it was burnt to bits. What do you think they were up to?

Deacon: Who knows. They should have put a call in, let us know what was going down

Johnson: Maybe they tried. We've got to find out what went on, before traffic do

Deacon: Or Sam Ryan. The moment Barrett comes round, I wanna know

Johnson: If he does

New Scene 10:19:12

A secretary brings two cups. Johnson is interviewing Nick at his office. They sit either side of Nick's desk

Johnson: So what did you do when you realised that the vehicle was missing

Nick: I called the local cop shop first thing, reported it stolen

Coffee arrives

Nick/Johnson: Thanks

Nick: Not on is it, eh? Out of my own car park

Johnson: No overnight security?

Nick: We keep cars there, not gold bullion

Johnson: So what time did you leave here?

SILENT WITNESS - THE FALL OUT - PART ONE OF TWO

Nick: Eight-thirty, nine. I always have a few drinks when I work late

Johnson: How did you get home?

Nick: Taxi

Johnson: Well, thanks for your time Mr Connors. We'll let you know when we've finished with your car, so your insurance people can take over

Picks up the phone

Nick: Thanks. You don't mind if I don't see you out do you? Got a client chomping at the bit

Johnson: No, sure

Nick watches Johnson leave then hangs up the phone. His secretary needs help

Rachel: Nick?

Nick: Yeah?

Rachel: I've got a problem getting the print outs for the end of the month

Nick: Why?

Nick stands, grimacing with pain. He goes to Emma's desk and picks up her handbag

Rachel: Emma hasn't shown and I don't know her password

Nick: Call her at home. Find it out

Music in 10:21:37 - Specially Composed - Duration 01:00

Flash back to Emma in the passenger seat of the Merc. Cut back to Nick then back to the Merc. Wide shot, Nick was the driver. Emma screams at the moment of impact

Emma: Want a cigarette? Sure?

New Scene 10:20:52

Sam, Leo and Harry enter the cutting room

Sam: We've a total of eleven fatalities. Six male adults, four female adults and one child

Harry: Do they know what happened yet?

Leo: Someone wasn't looking where they were going

Sam: No, they don't so anything we can give the police the better. Be on the look out for seatbelt

bruising or not, as the case may be

Harry: That wouldn't really be the cause of the crash, would it?

A technician uncovers a corpse

Sam: Well if someone wasn't wearing a belt and got distracted you never know. (to technician)
Morning

Harry: I suppose

They approach where Holly is laid out

Sam: Toxicology will check blood and urine for alcohol and drugs and don't forget to take stomach contents okay. And look out for any signs of heart attacks or other medical problems okay. Yours is the wee girl, are you okay about that?

Emma is wheeled past

Harry: Yeah, sure

New Scene 10:21:34

In the hangar the BMW is being winched off the back of a breakdown truck. Other vehicles from the accident are also there

New Scene 10:21:

In the cutting room Leo can be overheard as he begins on the burnt corpse. Harry starts Holly's post mortem. Deacon is wandering in the background

Leo: (oov) The body is that of a partially incinerated white male aged

He fades out as we move on to Sam and Emma's post mortem

Harry: The body is that of a young girl aged approximately six or seven years old. There are some abrasions to both her legs

Sam: The female is approximately between twenty-five, thirty-five years of age. Her injuries are extensive and the chest looks distorted. (to Deacon) I presume it's one of the fatalities you're interested in?

Deacon: Maybe more than one

Back to work as Deacon wanders past Leo and the burnt corpse

Sam: She could have cracked her sternum but there's a marked deformity between the breasts and evidence of extensive bruising

Deacon wanders back to Harry

Harry: There are no visible injuries to the head or the face. There is a large wound, approximately ten centimetres, a large wound in the chest which

He falters and stops. Just gazes at the small

body. Sam notices and gives him a warning
look. He must carry on

Harry: which is the probable cause of death.
There is severe bruising all around the wound,
suggesting it was caused by some object
impacting on the chest area

In the hangar, the family car is being pushed
across the floor
The stop and he applies the handbrake

Harding: Slow it down for me. That's it. Okay.
That's it. Keep going. That's it, great, perfect

New Scene 10:23:53

Paul is being interviewed at the hospital. Tara
leans against a wall

Paul: I hit my brakes and they just

Tara comes for a cuddle with her dad

Paul: Look, that's my partner in there and they
